1. I understand that PetMommy has relied upon my representation that my dog(s) is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog(s) for services at their facility.

2. I understand that PetMommy, their owners, staff and volunteers will not be held liable, financially or otherwise, for injuries to my dog(s), me or any property of mine while my dog is participating in services provided by PetMommy. I hereby release PetMommy of any liability of any kind arising from my dog's participation in any and all services provided by PetMommy.

3. I understand and agree that any problems with my dog, behavioral, medical or otherwise will be treated as deemed best by staff of PetMommy, in their sole discretion and in what they view as in the best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog(s).

4. I understand that there are risks and benefits with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by PetMommy and while in their care. **Keep in mind this is a social, group setting when choosing PetMommy to board/daycare. I understand that while the play and socializing is closely monitored by PetMommy staff to prevent injury, it is still possible that during the course of normal play, there may be a fight, minor scrapes, nicks, scratches, etc...from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick-up.**

5. I understand by allowing my dog(s) to participate in services offered by PetMommy, I allow PetMommy to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.

6. I understand that I am solely responsible, financially or otherwise for any harm or damage caused by my dog while my dog is attending any services provided by PetMommy.

7. I understand that if my dog(s) is not picked up on time or by date specified in a separate agreement, I authorize PetMommy to take whatever action is necessary for the continued care of my dog. I will pay PetMommy the cost of any such continued care upon demand. I understand that if I abandon my pet, I will be held financially responsible for all costs involved in the daily care, attorney/court costs, and all expenditures involved in securing placement.

8. I understand that the health and safety of all PetMommy clients and their human friends is of the utmost importance and that if my pet is found to have fleas/ticks that I will be charged for flea bath and Frontline flea application.

9. All daycare/boarder friends are required to have all shots and I understand I will provide proof of such and/or authorize PetMommy to validate shot records through my vet.

10. All fees are due and payable when services are rendered. I understand that PetMommy accepts cash or Credit /Debit card as acceptable forms of payment.

11. I agree to have a quick release collar on my pet(s) and an ID tag with my phone number and name.
